Alberto Figone, Supreme Court lawyer, is a member of the National Executive Council for A.I.A.F (the Italian Lawyers Association for family and for minors) and of the related local branch of the same association in the Liguria Region. He is also member of the editorial staff of the “Rivista”, published by the Italian Lawyers Association for family and minors, and serves as scientific Director of the A.I.A.F School of Education.

He is a visiting lecturer at the Faculty of Law of the University of Genoa, and, since the beginning of its establishment, professor of Civil Law at the specialization course for the legal professions of the same University, in which he also held courses in Ethics.

Professor Figone’s previous educational experiences include:

- Professor of Constitutional Law and Public Law at the Faculty of Education, at University of Genoa,
- Lecturer of Information and Communication Law at the Faculty of Education, University of Trieste,
- Teacher at the School of Notary in Genoa,
- Teacher at the Forensic Genoese School De Andrè, in which he held lessons both in the ordinary course and in the advanced course,
- Teacher at the "Milena Pini" A.I.A.F. training school,
- Speaker at several conferences on family and personal rights.

He also collaborates with different local councils of lawyers, private and public institutions, for the development of courses and review days dedicated to lawyers.

He is author of several articles, essays, notes, published in the leading law journals, and he is a member of the Scientific Committee of the Giuffrè online portal “Il familiarista”.
